## AB 23-21 – TIB Agreement

Brian Loos, Public Works Director, presented the agenda bill. Pacific County has worked with TIB to authorize the use of grant dollars to chip seal at other local entities. Through the interlocal agreement with Pacific County, the city can use their services without having to go through the formal bid process and pay prevailing wage.

C. Coleman made the motion to authorize the Fuel Tax Agreement with TIB for chip seal improvements. C. Svendsen seconded the motion; 5 Ayes, motion passed.

# AB 23-22 – AWC Conference Voting Delegates
